Hi Liz

I have been to Whalley an looked at the tree and the fallen branch of the Horse Chestnut at the Church yard.

The trees are covered by the CA. I will copy this note to Dave and Alex at RVBC for their views as my experience over the last 15 years or more indicates that the School Head Teacher and Governors and the Church and users of the PROW may have an interest in Pruning or removal decisions. I don't think we have to ask everybody what they think but the tree has reached a critical point in its life and the right decision needs to be taken.

The main points about the Horse chestnut tag 620 is as follows

- 1. Some 15 years ago a central cable bracing system was installed after the Junior school complained and we had meetings with the Head teacher governors and Parents regarding the risk if branch failure occurred and something fell into the School play area. Some trees were pruned and in the case of 620 the bracing system was installed to minimise the risk of harm.
- 2. The tree has suffered from bleeding canker for several years and only 60% of the butt circumference is bark covered. I would expect the tree to have a degree of central decay but hammer and drill tests suggest that catastrophic failure is unlikely. The yellowing of the leaf canopy suggests that the trees capability to transfer moisture and to photosynthesise is being compromised a cycle of decline may be starting.
- 3. The Horse chestnut to the north of 620 suffered a large limb failure in the recent past and was felled. This open space will have increased the wind effect on 620 so that when gusting winds occurred a few weeks ago the canopy had less protection and the 300mm dia branch failed into the churchyard. Photos of the failed union (Attached) suggest that timber decay was not the cause.
- 4. The highest value targets close to the tree are the children sometimes in the school play area and the Public right of way to the west. The west facing canopy has been reduced several times and the children's play area has a 7m exclusion zone on the churchyard side.
- 5. As the tree canopy is now more exposed to the prevailing winds, branch failure has occurred twice within the last two years and we seem to have greater likelihood of gusting winds in the future I feel that removal of 620 would be wise. The canopy could be dramatically reduce to 12m from 18m but Horse Chestnuts do not respond well to topping and such a pruning regime would look brutal within a Conservation Area. If the tree was fully removed to ground level there would be a 24m gap which could be filled with three select standard oaks able to fill the space over the next 50-100 years during which two further Chestnuts may need removal.
- 6. I recommend the felling and removal of the Tree 620 and replacement planting of three select standard oaks at 6m centres 1m clear of the Footpath Wall.

If Alex/Dave agree with my conclusions and your committee agree, I will propose removal and replanting.



ANNUAL TREE CONDITION INSPECTION: TREES WITHIN CHURCHYARD AT WHALLEY PARISH CHURCH

DATE: 9th December 2024

CLIENT: Whalley Parish Council

LOCATION: St Mary and All Saints, Whalley. Trees are all within the Whalley Conservation area administered by Ribble

Valley Borough Council

OBJECTIVE: To determine the extent of any hazard present and to schedule any works required and generally to enable the Client to discharge their duty of care to the local public and persons using the church and churchyard and Junior School. This annual survey updates the earlier survey and has been moved backwards to coincide with the possible evidence of fruiting bodies showing root and butt decay

SITE CONDITIONS: The trees were surveyed in wet clear conditions in late October. The trees were not climbed but Visual Tree Assessment methods and Digital Microprobe (Dmp) tests used to determine the extent of decay or indicators of potential hazard where appropriate. In the early part of 2023 a limb failure into the graveyard occurred. There was no damage to Grave stones or the public

Discussions were held with the landlady at the Dog Pub regarding the overhanging sycamore

CONCLUSIONS AND RECOMMENDATIONS:

- Removal of epicormics growth on limes is still outstanding from earlier and clearance of epicormics growth on the lower trunk of the roadside lime trees will enable inspection in 2024. Epicormic shoot pruning on mature limes enables butt tests to be carried out regularly. Basal and stem decay on limes is often not signalled by canopy growth and hammer or fine drill tests may be necessary. The epicormics growth is still evident and it would assist matters if the removal of the epicormic growth could be carried out before the end of March 2024. bUtt tsests can then be carried out in June 2025.
- 2. **The Sycamore removed from the school end entrance in 2022 has not yet been replaced.** We would recommend a Select Standard English oak, being slow growing and being in a key position in an iconic village landscape. The planting pit may need to be resoiled by .5m2 of good top soil.
- 3. The tree gap which now exists on the wall boundary with the PROW on the school boundary should be filled with a planting of a Select standard Oak Tree or a Hornbeam or lime. The wall has been yellow spot marked where the planting could take place.
- 4. Note boundary wall fractures close to three lime trees on pavement side Trees 523, 524, 525. These same trees have deadwood stubs over-reaching the pavement and road. Stubs with a diameter in excess of 35mm will justify removal given the residents car parking habits on the road.
- 5. The highlighted small items on the following schedule need to completed
- 6. The trees should be inspected again in June 2025 or after high winds or branch failures.
- 7. No tree can be regarded as totally safe. However the inspection has not brought to light any factors indicating a risk of failure or danger to the public that cannot be redressed by the scheduled works. The risk of harm is calculated using the QTRA system which regards the level of risk of 1:10,000 as set down by the HSE as being acceptable bearing in mind that no situation is ever free from risk.


