It was resolved that the minutes of the Parish Council Meeting held on 20^{th} March 2014 are approved as a correct record of the meeting.

685/14 to adjourn the meeting for a period of public discussion (information only)

Mrs Hanson highlighted that indecision by the developers at the Lawsonstead site and has had a negative impact on local householders.

686/14 to receive minutes of other Committees

The minutes of The Whalley and Wiswell Joint Burial Committee held on 7th February 2014; the Grounds and Gardens Committee of the 2nd January and the Planning Committee of the 20th March 2014 were presented to the meeting.

687/14 to receive reports of Councillors from other committees (information only)

Cllr Ronnan reported that the Grounds and Gardens committee confirmed the acceptance by Abbey Gardening Services for the annual lengthsmans contract and the bi-annual Vale Gardens contract. A monitoring of the water feature in Vale Gardens will take place and the stone seats on the bus station have been completed.

Cllr Barker has received representations from the community for mirrors to be erected in the vicinity of a. Broad Lane and b. the rear of Limefield to aid safe access for motorists onto Station Road.

Cllr Brown noted that the Almshouses meeting will take place on 9th May 2014.

Cllr Earnshaw reported that a clear up day will take place at the Joint Burial Ground on 29th April; new trees have been planted in the woodland; stain on the fence has been finished and a dog bin adjacent to the cemetery boundary is requested.

Cllr Kent reported that the Church Yard committee has received a letter from the Dog Inn alleging branches had fallen from the trees in the Church Yard onto the smoking shelter; the insurers have been notified. A number of trees that have previously been vandalised have now been illegally cut down in the Church Yard by persons unknown. The police are currently investigating this matter.

Cllr Highton attended the Parish Council Liaison Meeting at which superfast broadband implementation in the Ribble Valley was discussed.

It was resolved to accept the accounts for payments and receipts presented for March 2014.

Cllr Kent reported that he and Cllr Highton met representatives from RVBC who discussed the role of WPC, neighbouring PCs, local individuals and community

groups in shaping broad objectives. RVBC will provide advice on boundaries whilst WPC will consider how best to proceed and make recommendations.

Cllr Kent was thanked for his work and a further presentation will be made at the Annual Parish Meeting.
