	Members of the Council discussed the correspondence received from LCC ROAD TRAFFIC REGULATION ACT 1984 LANCASHIRE COUNTY COUNCIL (ACCRINGTON ROAD, WHALLEY, RIBBLE VALLEY BOROUGH) (REVOCATION AND PROHIBITION OF WAITING) ORDER 202* The Parish Council has significant concerns regarding the proposed parking restrictions on Accrington Road. Whalley already experiences considerable parking pressures, and the introduction of these additional restrictions would further exacerbate an already difficult situation for residents, visitors and local businesses. Whilst the Council recognises that maintaining safety at road junctions is an important priority, we will request that no restriction be introduced in relation to item (2a). In particular, the Council strongly objects to the proposed prohibition of waiting on the north side of Accrington Road, from a point 14 metres north-west of its junction with the centreline of Sydney Avenue, extending for a distance of 157 metres in an easterly direction. The Council will write to LCC and ask that serious consideration be given to omitting this element of the Order. Retaining the existing parking provision would help alleviate the already significant parking difficulties experienced by businesses on Whalley's high street and would support the sustainability of the village centre and its businesses, while still allowing appropriate measures to be taken to address road safety concerns.	2576/26
