Cllr Earnshaw reported on the clean up day at the burial ground.

Cllr Kent informed the meeting that there may well be a governance problem as the Church Yard committee may not be quorate following the retirement of the vicar. A letter will be sent to the PCC requesting the appointment of member to the committee. Tree branches in the church yard have been cut in accordance with the Tree Check report and a quotation has been received for work on the walls. He also noted that the Adam Cottam Trust had not as yet met.

Cllr Smith reported that Whalley Sports Community are to apply for charity commission status; he is applying for funding from a number of organisations; presentations regarding the proposals will be made to Whalley Lions and the Chamber of Trade and a press release will be issued soon.

Cllr Brown asked that a letter be sent on behalf of the parish council to the vicar on her retirement. She has received representations from the community regarding the indiscriminate parking now common in the village. The next Grounds and Gardens meeting will now take place on Tuesday 24th March, 7.30pm at the Old Grammar School.

Cllr Highton has been alerted to problems of litter and broken glass, along with concerns on parking control, at Whalley Arms car park.
