#### 781/15 to receive declaration of interests

#### 782/15 to approve as correct the Minutes of the Parish Council Meeting held on 20<sup>th</sup> November 2015

It was resolved that the minutes of the Parish Council Meeting held on 20<sup>th</sup> November 2015 be approved as a correct record of the meeting.

#### 783/15 to adjourn the meeting for a period of public discussion (information only)

A representative from Clitheroe Civic Society provided information on the project to save The Pinnacle in the Rose Garden of the castle grounds. An information sheet was circulated and further information and a petition can be found located in Whalley Library.

#### 784/15 to receive minutes of other Committees

The minutes of the Planning Committee meetings of the 20<sup>th</sup> November 2014 and 8<sup>th</sup> January 2015 were received along with the minutes of the Grounds and Gardens committee of the 25<sup>th</sup> September 2014 and the Joint Burial Committee of the 7<sup>th</sup> November 2014.

## 785/15 to receive reports of Councillors from other committees (information only)

Cllr Kent reported that the Church Yard committee met and considered issues with the path cleaning, wall repair and works to be completed by the tree surgeon; the Joint Burial committee discussed drainage finance, a new grounds maintenance contract and rate of interest for the finance. The Adam Cottam Trust has yet to meet.

Cllr Ronnan attended meetings at the Old Grammar School and reported that research is to take place into papers that have been archived at LCC, that the financial outlook is on course and that specialist surveyors are to be enlisted for possible works.

Cllr Brown reported that the lengthsmans van has been stolen. Replacement bulbs are to be bought and daffodils will be planted on Accrinton Road. The lengthsman will continue to work with volunteers and other organisations on behalf of the parish council. It was resolved at the meeting to contact the Pickwick committee to consider an overview of the xmas activities and designate role and responsibilities more formally.

Cllr Smith noted that a meeting of members of Whalley Sports Community Park would take place on  $28^{th}$  January.

Cllr Highton on behalf of the parish council congratulated the Pickwick Committee for a successful and enjoyable Pickwick night. At a meeting with LCC officers, councillors etc proposals were outlined in response to parking problems on King St. A consultation process will take place regarding a 2hour limited parking scheme. The double yellow lines at the pinch point near Cornmill Mews entrance are to be finally painted.

### 786/15 to accept the recommendations from NALC and SLCC regarding the 2014-2016 National Salary Award

It was resolved to accept the recommendations from NALC and SLCC regarding the 2014-2016 National Salary Awards for parish clerks. This would result in a £100 non consolidated (one off) payment for December 2014 and from 01/01/15 the clerks salary at SCP23, presently at £10.603 per hour would increase to £10.836 per hour
