Reference was made to item 714/14 that it should be recorded that councillors attended the Village Partnership meeting. With that inclusion it was resolved that the minutes of the Parish Council Meeting held on 19th June 2014 are approved as a correct record of the meeting.

723/14 to adjourn the meeting for a period of public discussion (information only)

Mr Brown wished to record his thanks to the Abbey Gardening Services team, especially Jordan, for the hard work not only throughout the year but especially prior to the Britain in Bloom judging. He recommended that a letter of thanks be sent by the parish council; He noted that another sign indicating "no ball games" be erected at Vale Gardens to deter footballers. Moreover, he lamented the lack of any police presence in Whalley and that representation should be made; He asked

for clarity from LCC Highways regarding the consultation process for proposed road/pavement alterations on King St.

Cllr Ronnans requests for a debate on the surgery for electors and inspection of the new QEII lease when completed was noted. He reported that the financial position of the Old Grammar School was on track.

Cllr Brown reported that modernisation of the Alms Houses was taking place. The Grounds and Gardens committee have updated the maintenance contract; confirmed that the electricity supply will remain intact; that the Whalley in Bloom plaques be displayed; the contractors plaque be removed; allow contractors time to resolve the water supply to the sculpture.

Cllr Sleight received confirmation that United Utilities would maintain the reservoir pools on the Lawsonstead site.

Cllr Smith reported that Whalley Action Group had met and printed copies of the Action Plan would be made available.

Cllr Earnshaw noted that at the AGM for "Save Whalley Village" it was resolved that the campaign would continue.

Cllr Highton reported that the Church Yard Committee was to instruct contractors to attend to the SW boundary wall; a coping stone is to be renewed; Tree Check have reported on the condition of the trees and that a tree replacement plan is to be instigated in liaison with RVBC conservation officers.
