### 951/16 to receive reports of Councillors from other committees (information only)

Cllr Ball (by letter) reported that The Adam Cottam Trust met to discuss options for the way forward regarding the restoration and repair of the Almshouses. The meeting was attended by a member of the Almshouses Association who gave advice on loans from the Association and other sources of finance. Further investigation on the works and costs is to be carried out before the Trust can decide on how to proceed.

Cllrs Barker and Brown reported the meeting with the Chief Executive of Calderstones NHS Trust at which he gave feedback on the recent inspection and future plans. Cllr Barker stated that the QEII documentation has been signed and forwarded to the solicitor. Cllr Brown has received representation from a resident of Clitheroe Road expressing concern on the tremors to the house foundations caused by the increase of heavy lorries. The resident has attempted to contact LCC with no success.

Cllr Fallon has received representations from members of the community regarding the fact that the new development adjacent to Hayhurst Road is named "Abbeyfields" thereby creating confusion as obviously one already exists; numerous potholes have been identified that require filling; the fence by Old Sols Bridge needs replacing.

Cllr Rimmer has again investigated the concerns of motorists who have to negotiate the potholes on the Calder Bridge.

Cllr Highton informed councillors that the recent Church Yard committee meeting was not quorate and will be re-scheduled.
