741/14 to receive declaration of interests

No declaration of interests were received

742/14 to approve as correct the Minutes of the Parish Council Meeting held on 21st August 2014

It was resolved that the minutes of the Parish Council Meeting held on 21^{st} August 2014 be approved as a correct record of the meeting.

743/14 to adjourn the meeting for a period of public discussion (information only)

Mr Reid stated that the 20mph limit road signs on The Sands and Church Lane were being totally ignored with the consequences that a serious accident will take place.

Mrs Hulland indicated that volunteers were available to weed/maintain etc the grounds of the Old Grammar School.

Mr Wedgeworth had noted that war memorials in other villages had planters and could this be a feature in Whalley. He added that the working relationship between the parish council and Whalley in Bloom has improved and every credit should go to Abbey Gardening Services for the contractors work at Vale Gardens and throughout the village. However he was strongly of the opinion that the removal of the plaque at Vale Gardens by the parish council, without consultation, was unacceptable. He asked for improved communication in the future.

Mrs Miller complained of the increase in weeds throughout the village but especially around The Sands.

744/14 to receive minutes of other Committees

The minutes of the Planning Committee of the 21st August 2014 were presented to the meeting.

745/14 to receive reports of Councillors from other committees (information only)

Cllr Kent noted that the Church Yard committee was to be arranged for September 22^{nd} . On that evening he would be representing the parish council at Barrow and Wiswell parish council regarding consultation on the possibility of a neighbourhood plan.

Cllr Ronnan requested support for the resurrection of the Whalley Lions Club.

Cllr Brown stated that dog fouling was on the increase and she was in communication with RVBC dog wardens. The Grounds and Gardens Committee is to meet on 25^{th} September.

Cllr Sleight informed the meeting that a green waste bin sign has been erected at the Joint Burial Ground in order to encourage users to separate the waste.

Cllr Smith stated that QEII trustees and the sports clubs were meeting monthly. He indicated that the MUGA needs to be constructed earlier rather than lately.

Cllr Highton attended the Parish Council Liaison Committee at which the LCC Parish Champion was in attendance.

746/14 to authorise the accounts for payments, receipts and balances for July 2014

It was resolved to accept the accounts for payments and receipts presented for August 2014. It was noted that the parish council has been awarded a grant of $\pounds 2,248.00$ from the RVBC Concurrent Functions Grant.
