As the applicant you will be responsible for:-

- Displaying notices at either end of the road sufficiently in advance of the event, and for removing the notices as soon as possible after the event.
- Directly informing residents, local businesses, schools, hospitals and surgeries, bus companies, parish councils and anyone else who may be affected by the event, sufficiently in advance of the event.
- Providing, maintaining and removing all signs and barriers associated with the restriction or closure, through an approved traffic management company.
- Ensuring vehicular access for emergency vehicles at all times during the event.
- Stewarding the event.
- Clearing the road at the end of the event.
- Repairing or funding any damage caused to the road or street furniture during the preparation of the event, the event itself or the clearing up operation.
- Funding any administration costs for the event.

  - •The length of King Street in the village of Whalley extending from its junction with Church Lane to the War Memorial at the junction with Station Road
- 2. The Order is made to avoid obstruction of the highways specified in paragraph 1 during the following event, Whalley Remembrance Day Parade
- 3.The Order shall come into operation at 09.30am on Sunday 9 November 2025 and will remain in force until 12.30pm on Sunday 9 November 2025.
- **4.**While the Order is in operation all traffic including bicycles and pedestrian movement along the road will be temporarily restricted (except for emergency access) between 09.30am and 12.30pm
- 5. There will be no alternative route available for the duration of the Order.
- **6.**All restrictions will be signed (and staffed) and will remain in force only for as long as is necessary.

- 7. Nothing in the Order will apply to:
  - Anything done with the permission of or at the direction of a Police Officer.
  - •Any vehicle being used for police, fire brigade or ambulance purposes or for the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which the Order applies.
- **8.**Access to properties adjoining the highway specified in paragraph 1 will not be affected by the Order.

9.All constables are hereby directed to enforce the provision of this Order.


