5. Path of Gas and Electric Supplies to Shawhouse Farm

David stated that planning permission had been granted to Shawhouse Farm to create a generating station to supply the national grid with additional energy. This is adjacent to Whalley, Wiswell and Barrow Joint Burial Ground. In order to build the station the developer was seeking and easement to run cables under the burial site and had made an offer of £50,000 plus legal costs. The Committee suggested that the developer seek permission to use the adjacent agricultural field as this would be less intrusive but were advised that this was allocated for housing.

6. Mitton Road Remembrance Garden and Crematorium

Cliff Ball reported that the Bishop has refused the Archdeacon's Petition that the grounds could be deconsecrated. The Council discussed the wish to obtain to access to the Graveyard for the 2019 Remembrance events. Councillor David Berryman agreed to make enquiries at the Borough Council.
